

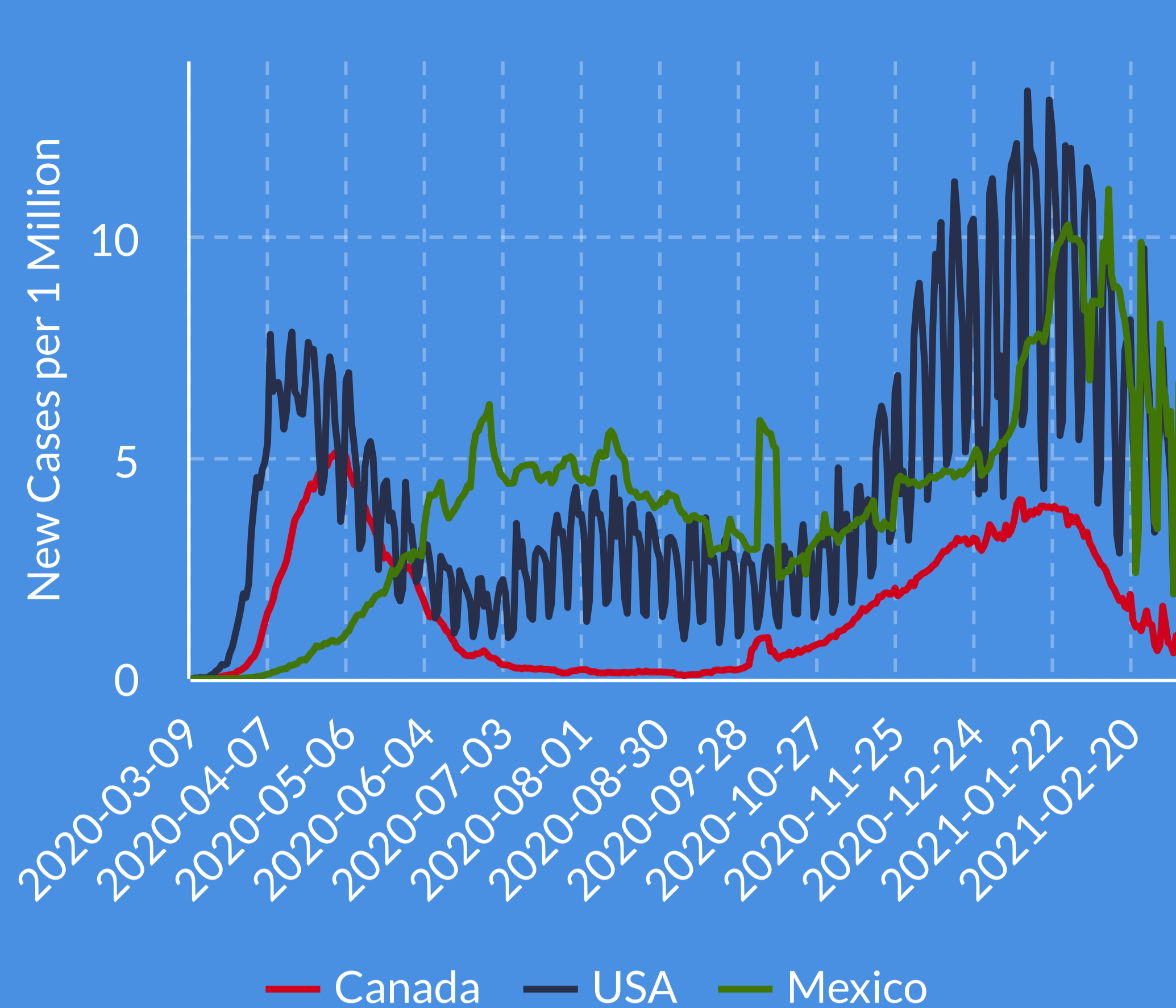
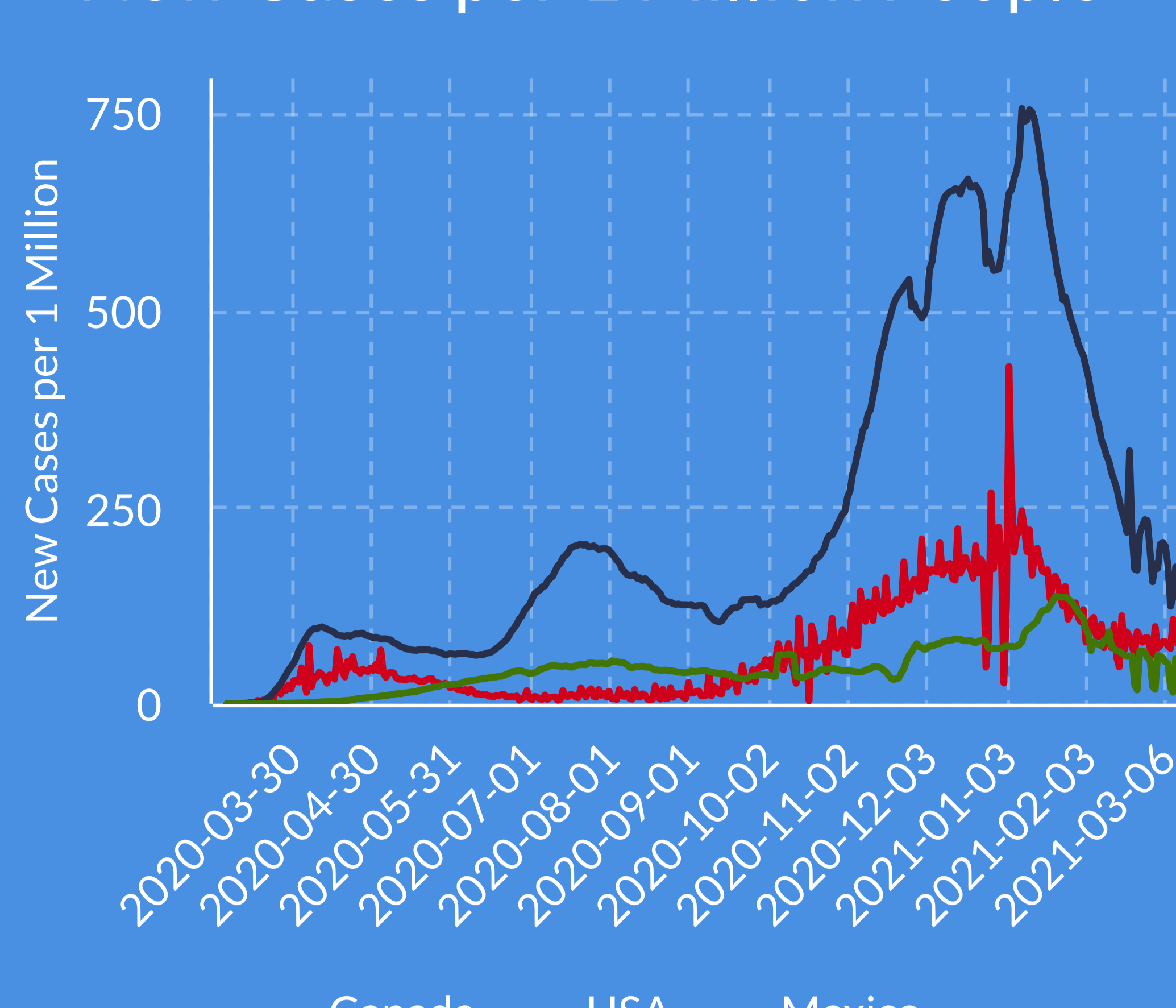

New Cases per 1 Million People

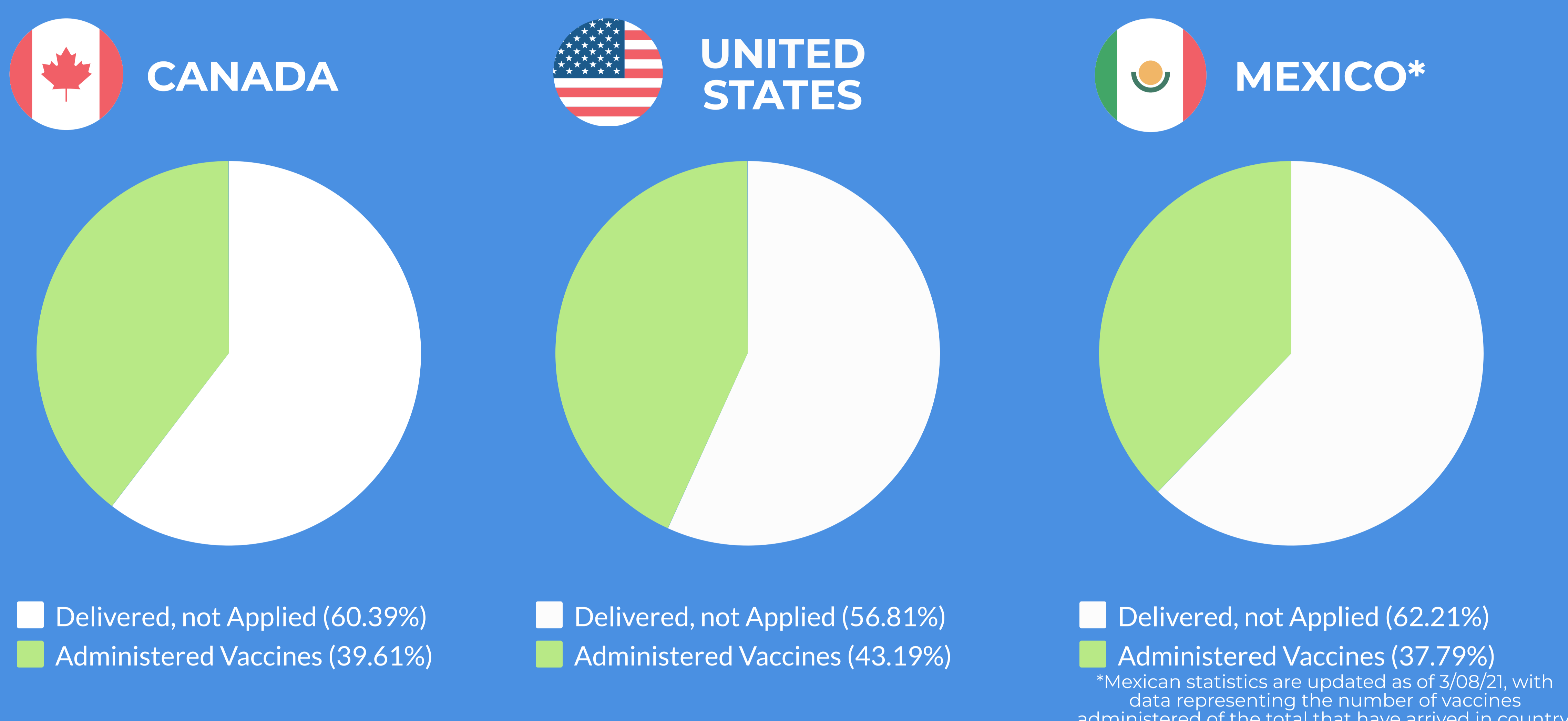
New Deaths per 1 Million People



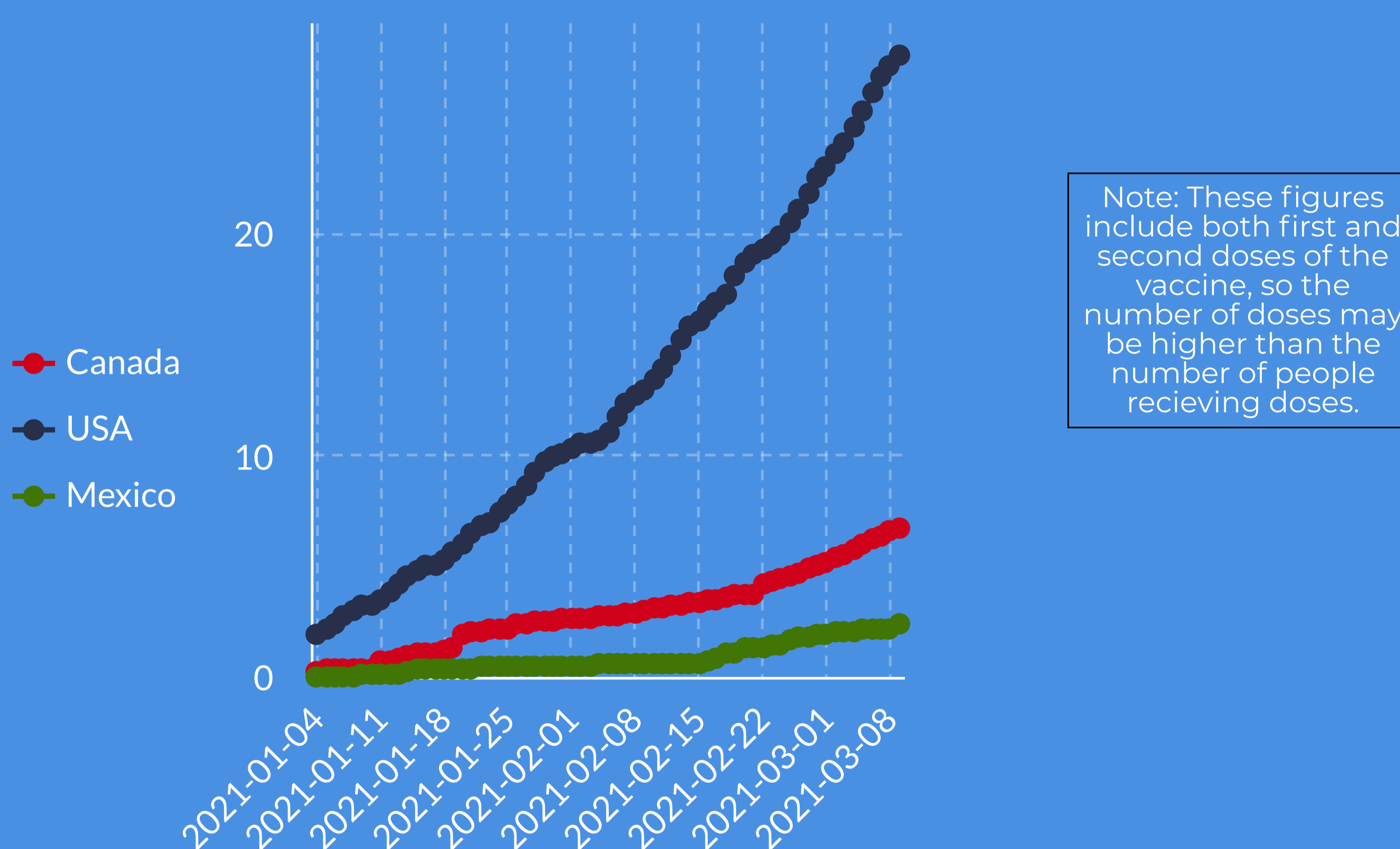
Comparison of COVID-19 Vaccination Efforts

Shows the percentage of vaccines at distribution sites that have been administered

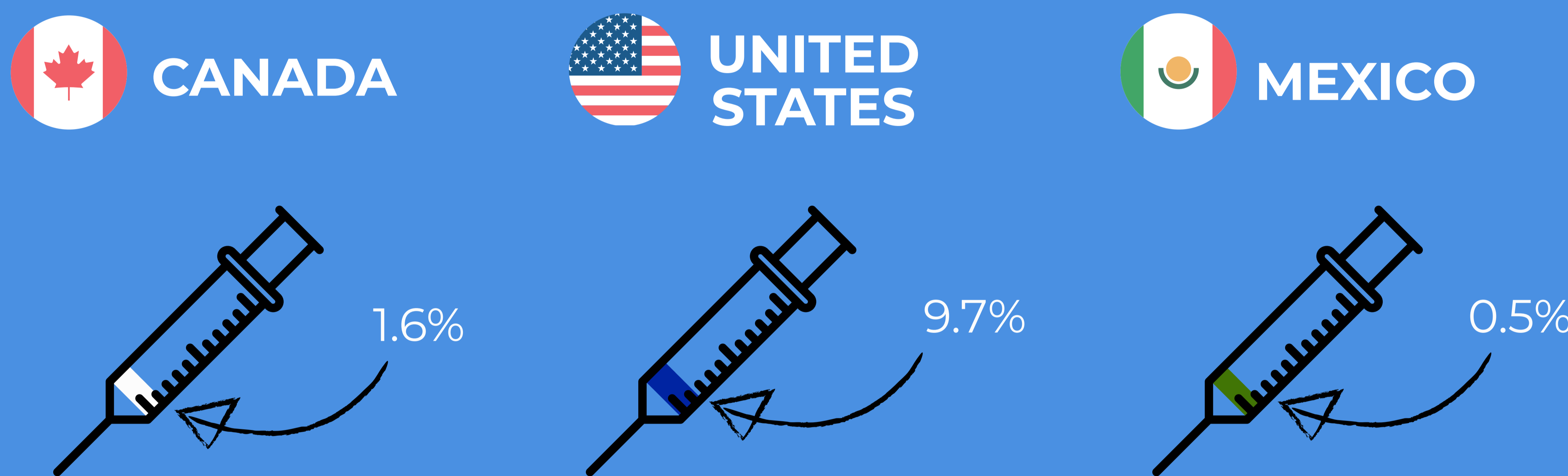


Vaccine Doses per 100 People



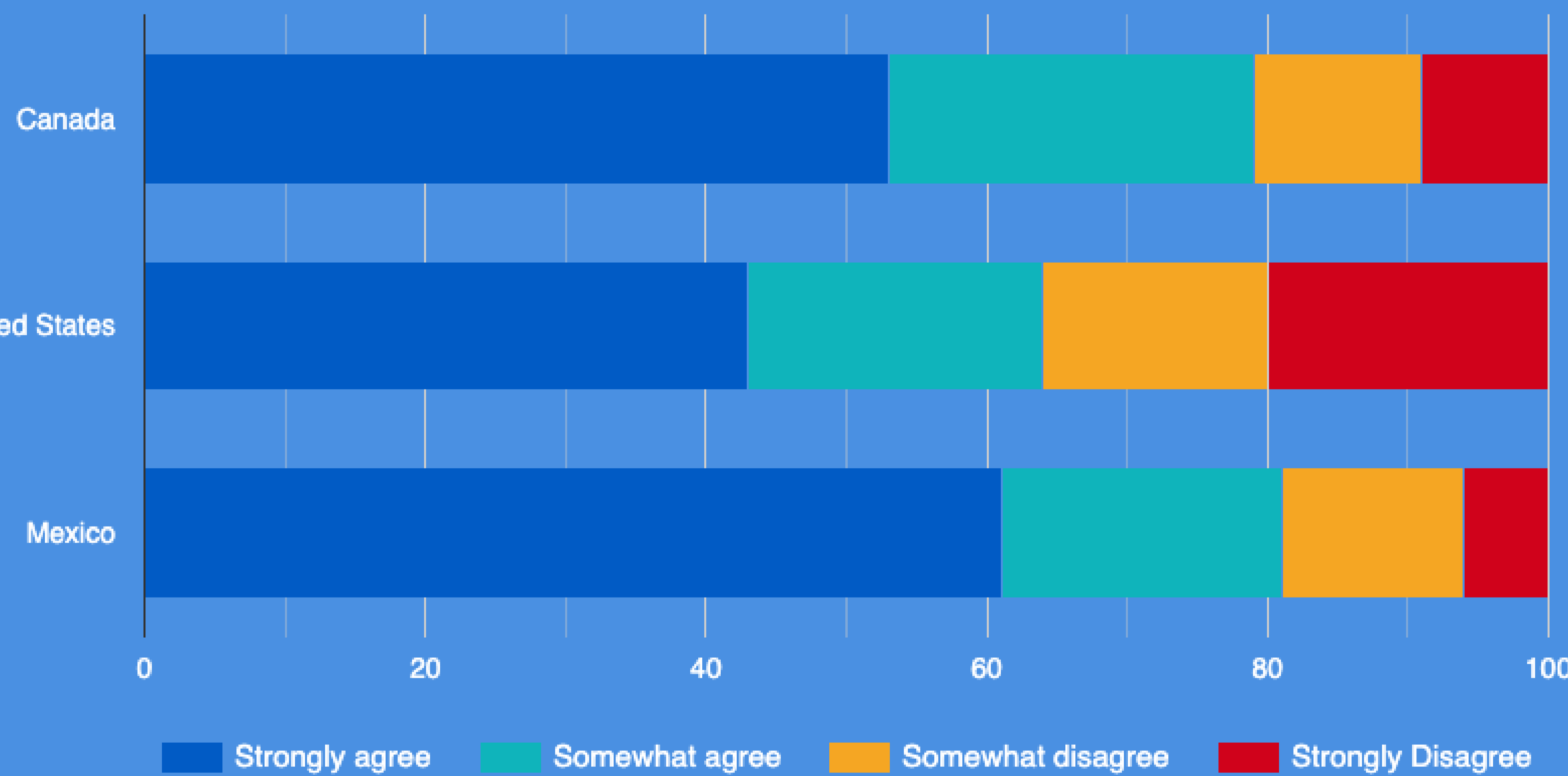
Percentage of Country Fully Vaccinated

Vaccination Roll Out Strategy

Country	Strategy
CANADA	Stage 1 Residents and staff of elderly care facilities, adults over 70, healthcare workers with direct contact with patients, and adults living in indigenous communities
	Stage 2 Residents of all group-living facilities, all healthcare workers, adults over 60, all adults from indigenous communities, adults from marginalized communities, and frontline essential workers
	Stage 3 People with underlying medical conditions, adults over 50, and non-frontline essential workers
UNITED STATES	Group 1a Healthcare personnel and residents of long-term care facilities
	Group 1b Frontline essential workers and people 75 and older
	Group 1c People age 65-75, people 16-64 with underlying medical conditions, and other essential workers
	Note States, provinces, and territories have authority over vaccine distribution in Canada and the United States.
MEXICO	Phase 1 (Dec. 2020-Feb. 2021) Frontline health personnel working closely with COVID-19
	Phase 2 (February-April 2021) All other health personnel and people 60 years of age or more
	Phase 3 (April-May 2021) People 50-59 years of age
	Phase 4 (May-June 2021) People 40-49 years of age
	Phase 5 (June 2021-March 2022) Rest of the population
